## ***From NY State Archives***

### **Promises to Keep: Preserving the Collections of 9/11**

The office of the New York State Archives is pleased to announce a series of free workshops for families, survivors and responders to be held in the New York metropolitan area this coming year.

Since 9/11, representatives from various New York cultural institutions have worked to ensure the survival of critical documentation surrounding the 9/11 tragedy. As a result, organizations and individuals have assembled collections of documents and artifacts like oral histories, letters, diaries, posters, maps, government reports, case files, photographs, memorial quilts and architectural remnants. There are significant challenges in preserving some of these materials, especially those recorded in formats that are short-lived, like voicemail, text messages, and websites.

The State Archives has developed special workshops for families, survivors, responders, and recovery workers. Designed for the non-archivist, the workshops will provide clear and accessible guidelines for preserving family treasures and mementos. Stay tuned as they bring this workshop to New York City venues as a service to the 9/11 Community.

### Financial Assistance Still Available from MA 9/11 Fund

### MA 9/11 Fund's Health Care Support Program Accepting Enrollees

Due to demand, the MA 9/11 Fund is pleased to announce that enrollees can still be accepted into the remaining eight months of the Fund's Health Care Support Program. This program offers eligible participants reimbursement for either half the cost of monthly health insurance premiums, or, for new enrollees, up to \$1,500 in out of pocket health care costs incurred from enrollment date through June 30<sup>th</sup>, 2008.
